How It Works

1. **Employer Registration** – Employers register online with their relevant Group Training Organisation (GTO) to register a trainee.
2. **Nominate InterCare as your RTO** – You and your employer lodge a training contract listing InterCare as your chosen RTO.
3. **Training Contract** – A formal agreement will be put in place between you and your employer, facilitated by Apprentice Connect Australia Provider (ACAP) to get you started.
4. **Enrolment & Compliance** – Complete your enrolment with support from us, including a Pre-Training Review (PTR) and Language, Literacy & Numeracy (LLN) assessment.
5. **Training Plan Approval** – InterCare approves your nomination and sets up your personalised Training Plan.
6. **Weekly Live Classes** – join interactive online classes with your InterCare Trainer every week via Zoom (2 hours per session).
7. **Flexible Assessments:**
 - **Online Theory** – Work through theory components at your own pace.
 - **Workplace** – Based Practicals – Complete practical assessments in your workplace, at times that suit both you and your employer.
